If your Meal Plan order is damaged during or upon delivery, please contact FYT kitchen staff at 231-252-2147 immediately. A refund for the damaged goods will be reimbursed to your original payment method within 2 - 10 business days.

If you select the "Pick-up" option for your order and do not pick up your order within 48 hours of

original pick-up date and time, the order will be discarded and you will not be provided a refund.

If you sign up for the Meal Plan Subscription service, you agree you are purchasing a continuous subscription and will receive Meal Plan deliveries weekly. Your subscription will be billed to your designated payment method until you cancel. You may cancel your School Program order up to 24 hours before delivery of your first order. The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the

event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. ### **Class Action Waiver**

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER.
